


# TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted







# TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




# **Source-Drain Diode Forward Voltage**




#### On-Resistance vs. Gate-Source Voltage







Single Pulse Power, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Ambient





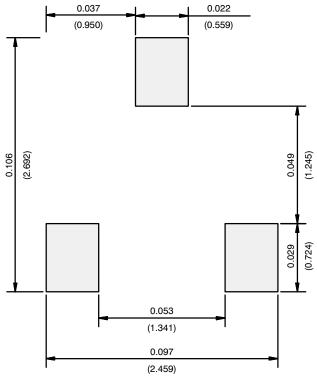
