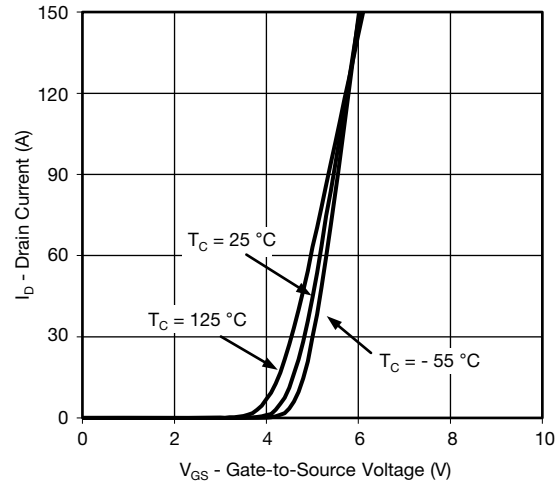

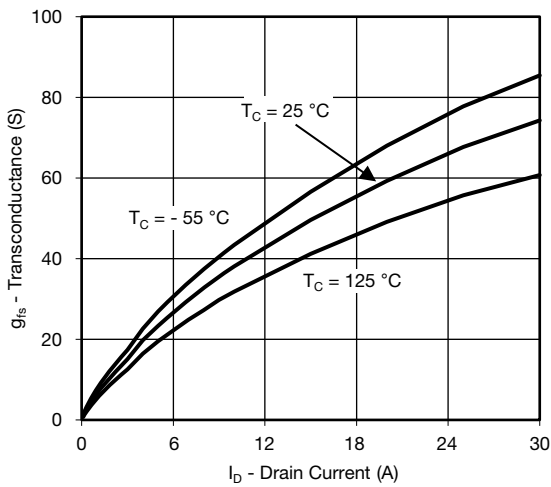

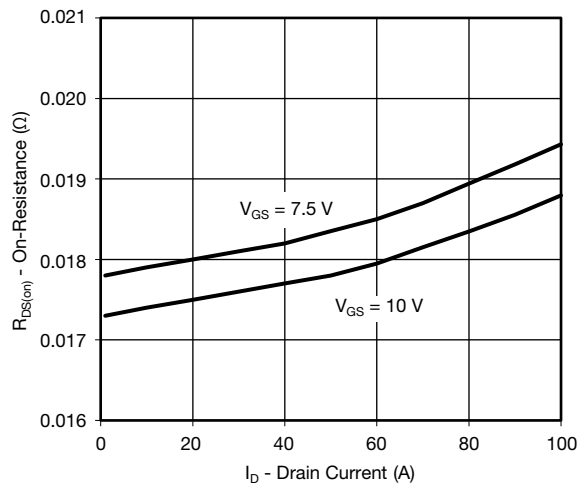
Output Characteristics



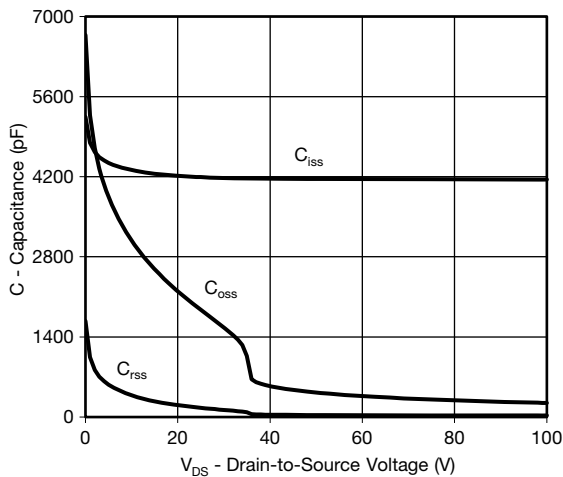
Transfer Characteristics



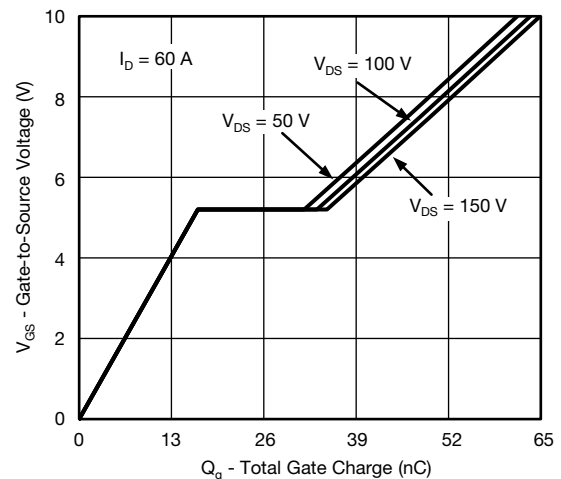
Transconductance

Capacitance

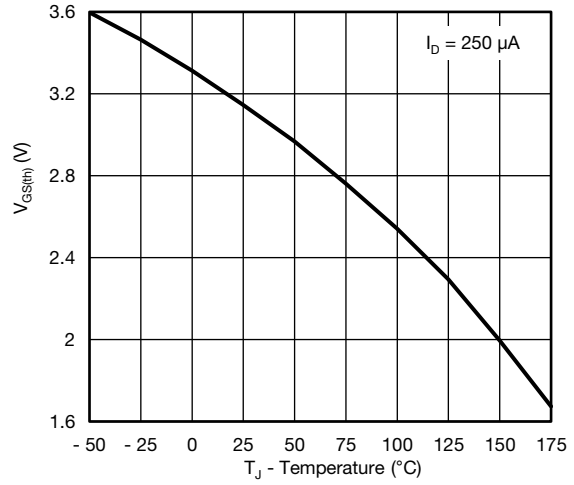

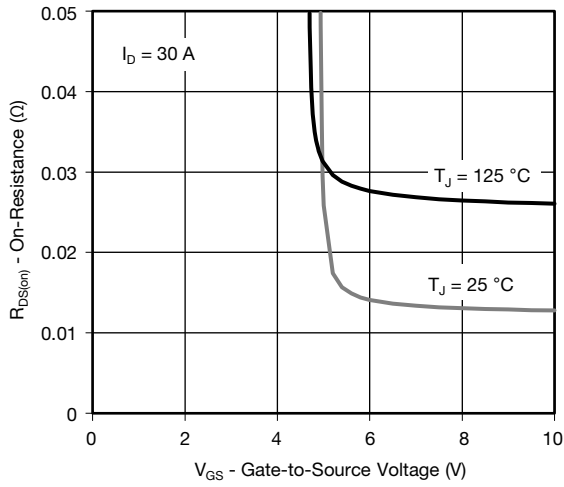

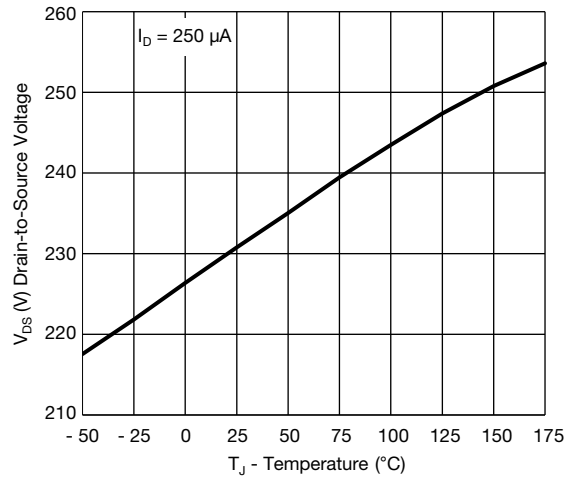
On-Resistance vs. Junction Temperature



Threshold Voltage



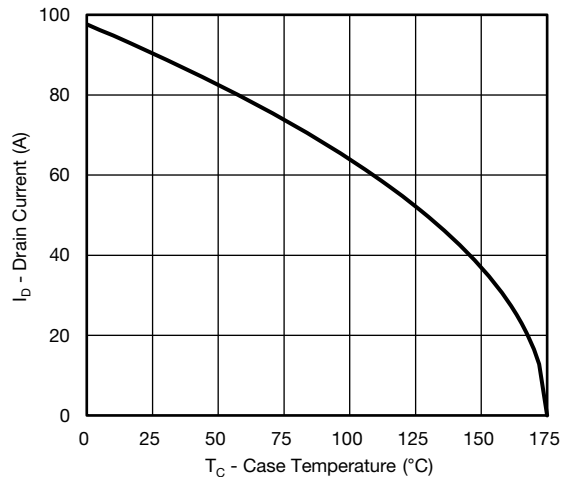
On-Resistance vs. Gate-to-Source Voltage
