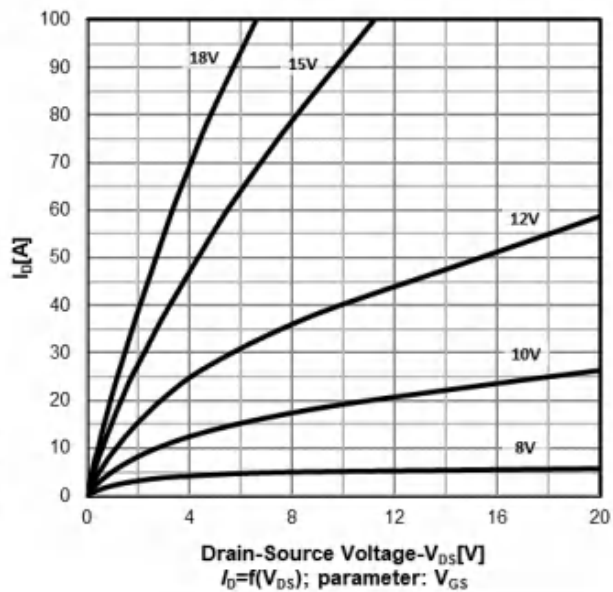

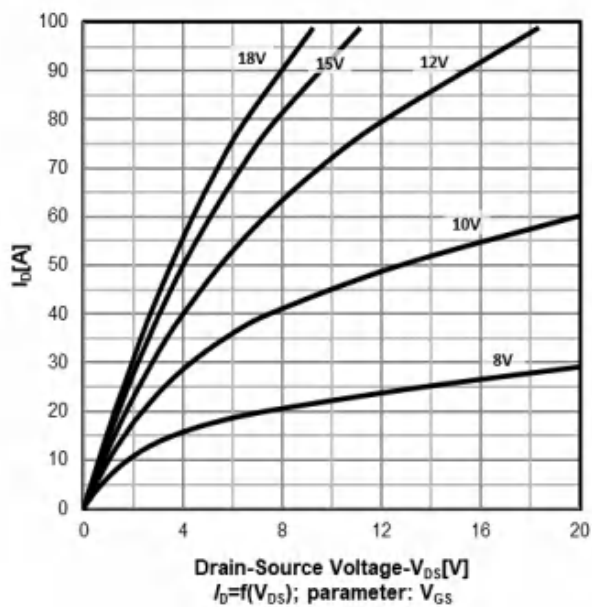

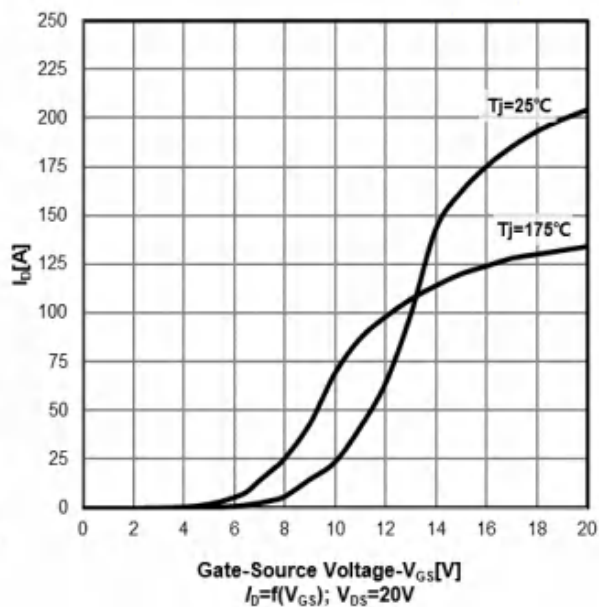
On-Region characteristics $T_j=25^\circ\text{C}$

Power dissipation



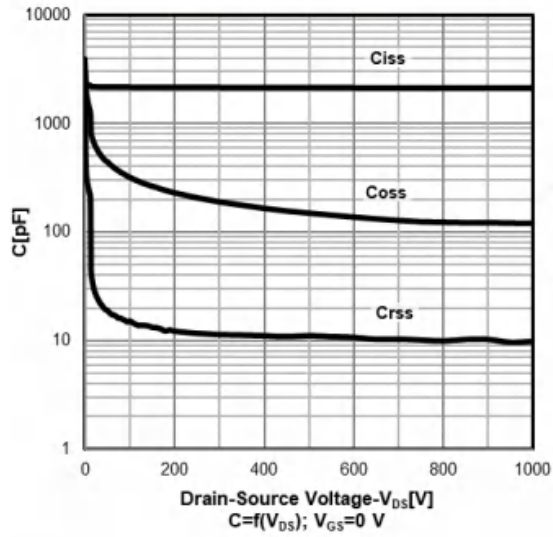
Threshold voltage vs temperature



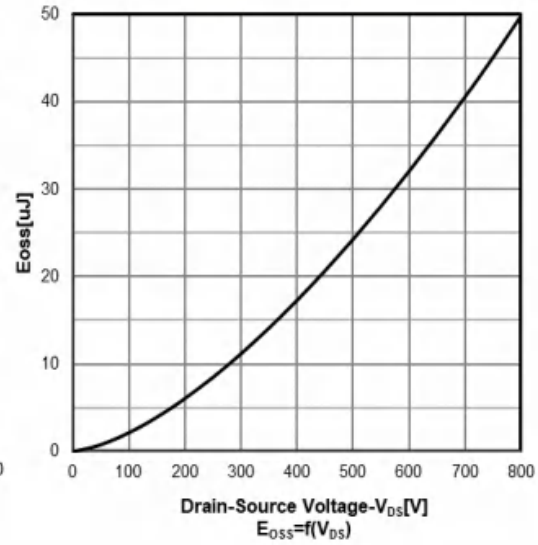
Normalized On-resistance vs temperature

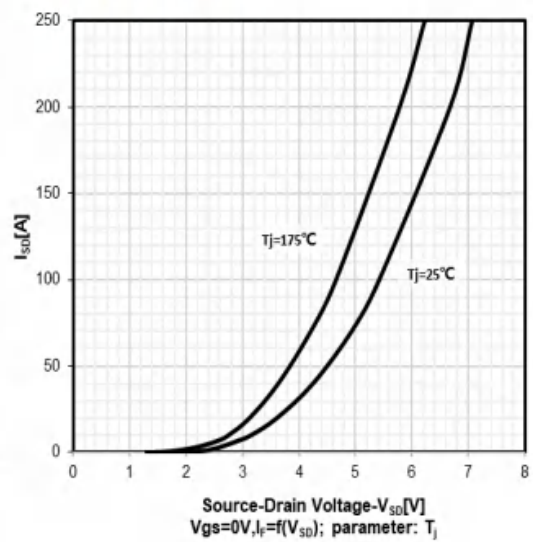
Coss stored energy
