



T_J - Junction Temperature (°C) Drain Source Breakdown vs. Junction Temperature





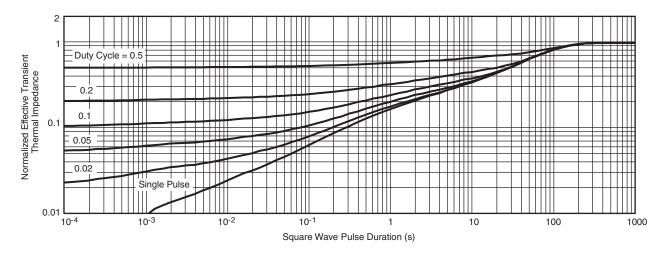


Safe Operating Area



Normalized Thermal Transient Impedance, Junction-to-Case






Normalized Thermal Transient Impedance, Junction-to-Ambient




